 - CCLS bought a new copier and the staff computers were upgraded

- 6. Election of System Trustees for their second 5-year term. Motion to elect Paul Benson, Don Butler, and Barb Kittle by Rhonda Thompson/Katie Smith. Passed unanimously.

- 8. New Business:
 - 21-22 construction grants applications totaled over \$508,000.00.
 - Motion to elect new Trustee Sandy Blood to her first 5-year term by Linda McCubbin/Beth Hadley. Passed Unanimously.
- 9. System Director's Report:
 - Advocacy efforts paid off in 2022
 - CCLS is updating the web site and updates are coming for a new look
 - There are three libraries going for a 259 vote in 2023, Minerva, Fluvanna and Bemus Point
 - The new delivery truck is in Buffalo and we expect it will be added to the fleet before year end
 - Revising book plan formulas to be fair to all libraries
 - New Trustee Education Requirements start January 1 2023. 2 hours of training each year for every trustee.
 - Construction grant applications have been submitted for 2022-2023. We now have a 90-10 match available if specific criteria are met along with the 25-75 match.
 - Jan is visiting Library board meetings to meet the trustees. She has visited 5 Board Meetings (are done) and 3 more are scheduled.
